IMPARTIAL BALLOT ANALYSIS FOR FORMATION OF HORNBROOK COMMUNITY SERVICES DISTRICT

The Siskiyou County Local Agency Formation Commission and the Board of Supervisors have approved the formation of the Hornbrook Community Services District with the functions of Domestic Water Supply and Sewage Disposal. The petition requested that a maximum tax rate of \$1.00 per \$100.00 of assessed valuation be established and that a 5 member Board of Directors be elected.

The proponents request formation of the Community Services
District in order to be able to obtain grants-in-aide and low interest loans to improve the water supply system and eventually to
construct a sewage disposal system. These grants and types of
loans are not presently available to the private water company.
The Community of Hornbrook was without water for a majority of the
summer evidencing the need for improvement of the system. Residents
of Hornbrook utilize private septic systems for sewage disposal.
Some of these systems have experienced problems in the past, and
as the community grows the need for a Public Sewage Disposal system will become critical.

If the district is formed there will be an increased taxes to the property owners. However, since low interest loans and grants are available to a Services District and not to a private water company, the overall increase for the improvements is expected to be less than if the improvements were made by the existing water company and the costs passed on to the users through increased fees.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Board of Supervisors of Siskiyou County will hold a public hearing in the Board of Supervisors Chambers, Courthouse, Yreka, California, on Tuesday, December 13, 1977, at the hour of 11:00 A.M., on the proposed formation of the Hornbrook Community Services District.

The petition for formation of the proposed Hornbrook

Community Services District is on file and available for inspection at the office of the County Clerk, Courthouse, Yreka,

California.

The proposed boundaries of the Hornbrook Community Services District include the present communities of Hornbrook and Henley and those surrounding areas presently served by the existing private water company.

The function proposed to be performed by the District will be to provide a domestic water supply and sewage disposal within the land covered by the proposed District. The estimated income and expenditure for the first year of operation for the District is \$5,455.96. The estimated initial annual special and ad valorem tax rate to the taxable property within the proposed district shall be \$1.00 per \$100 assessed valuation.

Any interested party may appear at the public hearing, either for or against the formation of the proposed Hornbrook Community Services District and written requests for exclusion from or inclusion of land in the proposed district will be heard and considered.
