- 1. Call to Order: Meeting called to order at 6:02pm. Roll call Robert Puckett, Elaine Mellon, Melissa Tulledo, Bryant Schauffler and John Moody present, Quorum established:
- 6. Consent of Board Members to jump to #6 first: Discussion and Posssible Action: Much discussed about well #5, electricity to well #5, building block or wood frame, size pump, 10 or 15 horse, build shed over #2 and #5 wells. Board voted to go three phase power to number #5 well for 15 horse pump at approximately 160 gallons a minute with the ability to hook up a generator if need be. Motion made by Bryant and seconded by Elaine, 5 ayes o nays. Another motion made by John Moody to go ahead and build well #2 building with cinder blocks since money is already there from Cal.OES and DDW. Seconded by Bryant, 5 ayes o nays. Garett to get prices on wood building vs cinder block building. Larry Griebs suggested building well #5 with blocks for security reasons since it is next to road:
