## MINUTES

**BOARD OF DIRECTORS:** Robert Puckett, Elaine Mellon, Melissa Tulledo, Michele Hanson and Reagan Duncan

- 1. Call to Order: Meeting called to order at 6:06pm with Robert Puckett, Elaine Mellon, Melissa Tulledo, Bryant Schuffler and John Moody running late but will enter meeting. Quorum established. While waiting for Moody to arrive the Board will skip down to item 3 until he is able to vote on Item 2.
- Election Of Officers: Need to elect, President, Vice President and Secretary of the Board:
   President- Tulledo nominated Puckett for President with no objections the vote began, with 4 ayes, 0 nays and 0 absent. Puckett elected.

Vice President- Puckett nominated Mellon with no objections, 4 ayes, 0 nays and 0 absent. Mellon elected. Board Secretary- Puckett nominated Tulledo with no objections, 4 ayes, 0 nays and 0 absent. Tulledo elected.

- 3. Public Comment: The Chair will ask each member of the public if they wish to make a comment at this time to avoid confusion and retain order and will be subject to 3 min. each. Then again after each agenda Item. Matthew Post commented he is unable to dial fast enough to get into the meeting.
- 4. Approve and Authorize Signatures: on Warrant Authorization Form for District expenses received through Dec. 20, 2021, "A list of the bills to be paid will be read to the Board and public at the meeting. Including payroll:

Puckett read aloud to the public and the Board the list of bills to be paid including payroll. With one correction. The second payroll date for Dingman needs to be changed from 10/30/21 to 12/15/21. With that correction Schuffler moved to authorize and approve all bills. Mellon 2<sup>nd</sup> the motion with 4 ayes 0 nays and 1 absent. Motion carried.

At this time Moody joined the meeting so the Board will go back to item 2 and elect the officers.

- 6. Discussion and Possible Action: Re-Authorizing Remote Teleconference Meetings of the Board of Directors of the Hornbrook Community Services District: Resolution #2021-008: Puckett went over the resolution and pointed out this resolution is from Dec. 30, 2021 through January. 30, 2022. - 7. Discussion and Possible Action: Amend Declaration of Water Shortage Emergencey Resolution 2021-002 from 200 gallons of water a day per household (pg3, #7a) to 300 gallons a day per household: also 7b, 7c, 7c-1, and #8, and #9 of Resolution 2021-009.
  Moody moved to adopt Resolution 2021-009, 2<sup>nd</sup> by Tulledo with 5 ayes, 0nays, and 0 absent. Motion carried.
- 8. Discussion and possible Action: Change Meeting Time and Day: The Board discussed changing time and day of meetings to enable new Board members to attend due to work conflicts. Schuffler moved to change the meetings to the second Monday of each month and the time at 6:00pm. Was 2<sup>nd</sup> by Mellon with 5 ayes, 0 nays and 0 absent, Motion carried.
