- 1. CALL TO ORDER: Roll Call: Puckett, Mellon, Hanson, and Tulledo present and Duncan absent. Meeting called to order at 5:07 pm.
- 2. Public Comment: Due to the circumstances, the Chair will ask each member of the public if they wish to make a comment at this time to avoid confusion and retain order and will be subject to 3 min. each. Then again after each agenda Item.

Amy Evangelista asked if we were going to have water this summer. Puckett assured her we were. He then explained we are getting funding to install a new well hopefully within the next few weeks. Which we will then have 4 working wells.

larry Grieb asked if a flocculation plant was an option to keep using the creek. And how long will we be able to stay on the creek. Puckett told him that the creek will be drying up as soon as summer hits. But he would get a hold of Barry Sutter and find out how long the state will allow us to remain on the creek.

3. Approve and Authorize Signatures: Warrant Authorization Form for District expenses received through March 15, 2021, "A list of the bills to be paid will be read to the Board and public at the meeting. Including payroll.

Puckett read the bills as presented including Dingmans payroll for the month.

Hanson made a motion to pay all bills as presented and a 2nd by Mellon, with 4 ayes, 0 nays, and 1 absent Motion carried.

4. Discussion and Possible Approval of Minutes: Meeting minutes of February 15, 2021.

February 15, 2021 were presented without any corrections. Motion to except minutes was made by Hanson and 2nd by Tulledo with 4 ayes, 0 nays and 1 absent. Motion carried.

5. Update on OES Funding: Puckett updated the Board on the funding.

OES funding is there and is ours but still waiting for all the T's to be crossed and the I's are dotted. It takes time but it is moving forward. We are in the process of getting funding for a new well to be drilled. It will be a test well and if the well is good then it will become permanent. This will be funded through a different agency. Not sure who that will be yet. OES and SWRCB are fast tracking that so we can expect the test well to be dug in the next few weeks.

6.
