**9 Discussion:** Everyone should have received a short copy of Resolution 2023-005 in the mail last month after the special board meeting of June 15, 2023 lifting the water usage to 50,000 gal per month. Just remember what section 7,# iv says, “ **Excessive Use Violation Exception: In the event a customer uses more than 50,000 gallons of water in a given billing period, even if such use is a first time violation, the District is hereby giving notice that a written notice of violation shall be issued and the District shall be authorized to install a flow-restricting device, without a prior written warning, on that customer’s service line whose water use is excessive and egregiously exceeds the water usage limit set forth in Section 6(a) of this Declaration of Water Shortage Emergency. Charges for the installation and or removal of flow-restricting devices or restoring service may be fixed by the District Board of Directors from time to time. ”**
